Before your application will be considered, payment for the full amount of the membership or a signed Dues Payment Plan must accompany your application. You will receive notification of your acceptance in one of several ways:

- 1) Your check has cleared the bank (checks are held until approval by the Board).
- 2) E-mail notification.
- 3) Written notification. Written notification or paper newsletters will not be provided unless you have purchased those items as an option during enrollment. The Club communicates through e-mail and website newsletters. It is vital to have and maintain a valid e-mail address.

You will receive notification of acceptance usually prior to July 15.

A **REQUIRED ORIENTATION**, will be held after which time you will receive all rules, regulations and access to maps of each lease. You must complete orientation by August 30th.

Failure to complete orientation by this date will result in the rejection of the membership by the club. The membership fee will be refunded to the applicant minus a 25% administrative fee of the amount paid. The membership packet which includes individual membership cards & tags, lease instructions and maps will be held until the required orientation is completed.

The membership term runs from September 1 of the current year through August 31 of the following year.

Edmond Sportsmen's Club New Member Dues Payment Plan 2011-2012

The ESC Board of Directors is offering an optional payment plan for new members. If you desire to pay your membership using the payment plan, complete the following form and return with your membership application and first payment.

If you do not make the required payments or seek a refund of payments there will be a \$50.00 administrative fee if the request is made prior to June 1, 2011. Any request for refund after June 1, 2011 will result in an administrative fee of 50% of dues paid. All payments must be received by August 1, 2011 or your membership will be terminated and a refund of 50% of the payments collected will be returned.

The Club must have all monies in the bank to pay for the lease package for this hunting season. This payment plan is for your **hunting club membership dues only**. If you desire guest passes, newsletters etc. you must pay for those items in full when you return this agreement.

If you accept this payment plan and you have not received confirmation of acceptance to the Club, you must still meet the payment schedule or be prepared to make up prior missed payments upon notification of acceptance to the Club. If you are not accepted to the Club, all payments will be returned in full prior to August 1, 2011.
